#### II. SUMMARY

Each FEMA award is a new phase of funding; therefore, the Local Board is a new entity in every phase. The convener of the National Board must ask each Local Board agency to designate or re-designate a representative to oversee functions performed by their Local Board. Other invited agencies must also designate or re-designate a representative each year. Each agency represented on the Local Board should have an alternative from their agency to attend meetings when the designated board member is unable to attend. If there is more than one representative from an agency / organization present, only one vote is allowed for the agency / organization. FEMA requires that the Local Board be represented by American Red Cross, Catholic Charities, The Jewish Federations of North America, and The National Council of the Churches of Christ in the USA, the Salvation Army and United Way, with special emphasis on elderly, families with children, veterans, along with mentally and physically disabled persons. Letters have been sent out to invite individuals to fill the areas of The Picayune Rancheria of the Chukchansi Indians, The Jewish Federations of North America, and The Council of the Churches of Christ in the USA.

#### III. DISCUSSION

- 1. Each phase of FEMA funding will require a new representative or redesignated representative to fill chair positions.
- 2. Positions for election or re-election are Chair, Vice Chair and Fiscal Reporter.
- 3. Votes will be cast to elect or re-elect Local Board members to fill chair positons.
- The Chairperson will conduct the Local FEMA Board meeting and serve as signer on behalf of the Local FEMA Board to the National FEMA Board.

#### III. RECOMMENDATION

#### II. SUMMARY

The Emergency Food and Shelter National Board Program (EFSP) is a Federal program administered by the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) and has been entrusted through the McKinney-Vento Homeless Assistance Act (PL 100-77) "to supplement and expand ongoing efforts to provide shelter, food and supportive services" for the nation's hungry, homeless and people in economic crisis. The Phase 41 allocations for Madera County were announced January 17, 2024.

It is the responsibility of the Local FEMA Board to select the recipients of FEMA funds. Funded agencies, known as "Local Recipient Organizations" (LRO's), must use EFSP funds for mass shelter, mass feeding, food distribution through food pantries and food banks, one-month utility payments to prevent service cutoffs, one-month rent/mortgage assistance to prevent evictions or assist people leaving shelters to establish stable living conditions.

#### III. DISCUSSION

- A. FEMA Phase 41 applications were sent out to the Local Recipients and Board members on October 5, 2023, by e-mail. Applications were due back to CAPMC no later than October 27, 2023, at 5:00 PM.
- B. An ad was placed in the Madera Tribune on October 14, 2023, and ran for 10 days to advise other agencies of funding.
- C. The FEMA Local Board shall appoint a ranking committee that will meet separately to review the FEMA applications and make a recommendation for funding. Below is a summary of how the applicants will be reviewed and ranked. Responsibilities of The Local FEMA Board Ranking Committee will be as follows:
  - Review the applications of proposals by applicants using the set Interview Questions
  - 2. Rate proposal using Selection Criteria Sheet
  - Total points to convert a percentage score
  - 4. Select proposals that will be funded
  - 5. Select amount at which proposals will be funded
  - 6. Those agencies requesting funding are excluded from voting in the ranking committee
